Consultation in accordance with Articles 5 of the Espoo Convention on Environmental Impact Assessment in a Transboundary Context (Espoo Convention) regarding Kaunis Iron AB (KIAB) permit application for continued and expanded mining operations at Tapuli, Palotieva and Sahavaara mines with associated operations at Kaunisvaara in Pajala municipality.

In 2021, the Swedish Environmental Protection Agency (SEPA) invited Finland in accordance with Articles 4 and 5 of the Espoo Convention to comment on KIABs permit application and assosiated environmental impact assessment. Due to comments received, KIAB has now prepared a reply to received comments and additional investigations. SEPA now invites Finnish authorities, organisations and the public to take part of and a possibility to comments on KIABs reply and the new documentations provided.

The planned project

The activities included in the application regards mining operations in the form of mining up to 20 million tonnes of ore per year in open pit mines at Tapuli, Palotieva and Sahavaara, Pajala municipality. In addition, the application includes processing of the ore in Kaunisvaara dressing plant in Pajala municipality and intake and discharge of water in the border river Muonio Älv and disposal of extractive waste (enrichment sand, waste rock, moraine peat). Sub-quantities of the waste are potentially acid-forming and constitute hazardous waste.

Due to the additional mining and enrichment of the Palotieva and Sahavara ores, the planned activities require e.g. an expanded project area and expanded water operations that affect the Natura 2000 area, Torne and Kalix river system.

Upcoming process

The Swedish environmental court in Umeå has now planned the dates for the main hearing of the case in Pajala, starting the 29th or 30th of August with preliminary last date the 16th of September. All eventual comments to the additional documentations will be translated into Swedish so that the company can respond to these at the latest in connection with the main hearing. The court's decision shall be announced within two months after the main hearing was concluded.
