Type approval decrees, which have been given according to the former regulation in the Land Use and Building Act 13 § have expired in the end of 2017; most of the type approval decrees have expired in the end of 2017. The ones which are not given according to the former 13 § are normally in force, for example ministry of the Environment Decree on the Type Approval of Weldable reinforcing steels and reinforcing steel nets (it has been given according to law 954/2012, 6 §). Please notice that type approval is only possible for product groups that have a valid specific type approval decree. Those type approval decisions, which have been given before the expiration of the current type approval decree, are going to remain normally in force as the specific type approval decision and the law states (Type approval is granted for a specific period, for a maximum of five years at a time). Certification of quality control is possible for those decisions.
