Notification of the Strategic Environmental Assessment of Estonian Marine's Strategy Programme of Measures 2022–2027 implementing the EU Marine Strategy Framework Directive (MSFD, 2008/56/EC)

In a letter dated February 14, 2022 Estonia notified, in accordance with article 10 of the Protocol on Strategic Environmental Assessment to the United Nations Economic Commission for Europe's Convention on Environmental Impact Assessment in a Transboundary Context (Espoo Convention), its neighboring countries concerning the initiation of Strategic environmental assessment (SEA) of the draft updated Estonian Programme of Measures 2022–2027 implementing the EU Marine Strategy Framework Directive (MSFD, 2008/56/EC). Finland, Latvia and Sweden indicated their wish to participate in the transboundary SEA procedure of the Programme, based on the view that the adjacent waters and shared sub-basins may be significantly affected by the implementation of the proposed Programme. With this letter Estonia wishes to notify Finland, Latvia and Sweden about the SEA report.

Background

The purpose of the Programme is to update Estonian Marine Strategy's Programme of measures approved by the Government of the Republic in 2017, in order to ensure the fulfilment of the established environmental targets and thereby achieve or maintain the good environmental status of the Estonian maritime area. The updated draft Programme 2022–2027 suggests 21 additional measures specifically devised for achieving the MSFD objective of a good environmental status of marine waters.

We wish also to highlight that during the preparation of the Programme of measures, international cooperation and coordination has taken place under HELCOM. Cooperation included the sharing of information with HELCOM Contracting Parties on the national measures and the identification of opportunities for regional measures or joint actions, ensuring that HELCOM decisions and recommendations, including the updating of the Baltic Sea Action Plan, will be taken into account in the drafting of the national Programmes of measures. Estonia will continue to seek coordination with HELCOM Contracting Parties on the Programme of measures and its implementation as part of the regional coordination process in the marine Regions of the Baltic Sea.

The SEA report

The scope of SEA report includes identifying, describing and assessing the significant strategic environmental impact that the implementation of the measures planned in the programme of measures may have and, if necessary, proposing measures to mitigate and/or prevent negative environmental impact or enhancing the positive impact; giving an assessment of the internal consistency of the measures developed in the programme of measures and its relations to national and international environmental goals.

According to the agreement between Estonia, Finland and Latvia, we attach the SEA report extended summary in the respective languages.

- submit any comments you might receive from the public and authorities in your country regarding the summary of the SEA report.
