Pursuant to Article 11 of the Protocol on Strategic Environmental Impact Assessment please be advised that Polish Nuclear Power Programme was adopted at the beginning of 2014.

The Programme is a strategic document covering the entire territory of Poland. The Document does not constitute the grounds for granting permits for implementation of nuclear projects in Poland, as it only indicates potential locations for future nuclear facilities. Let me emphasise at this point that in the event of a future decision by the Republic of Poland to launch construction of a nuclear power plant in a specific location in Poland, a comprehensive Environmental Impact Assessment will be performed in accordance with the provisions of *Council Directive 2011/92/EU on the assessment of the effects of certain public and private projects on the environment.* In such event countries covered by possible transboundary environmental impacts will be officially notified in accordance with the Convention on Environmental Impact Assessment in a Transboundary Context (Espoo).
